Re: Application by 130 Environmental Park, LLC for MSW Permit No. 2383; TCEQ Docket No. 2015-0069-MSW; SOAH Docket No. 582-15-2082.

A Proposal for Decision and Proposed Order was mailed by the State Office of Administrative Hearings (SOAH) to the parties in the above-referenced matter on February 17, 2017. SOAH set the following deadlines for exceptions and replies: exceptions were due to the Texas Commission on Environmental Quality's (TCEQ) Chief Clerk by not later than March 9, 2017 and replies were due to the Chief Clerk by not later than March 20, 2017. On March 7, 2017, counsel for TJFA, L.P. and Environmental Protection in the Interest of Caldwell County (collectively, Protestants) filed a request to extend the deadlines for filing exceptions and replies.

In accordance with 30 TAC § 80.257(b) and the Commission's Resolution issued on February 2, 2009, Docket No. 2009-0059-RES, the deadlines for exceptions and replies to the above-referenced matter are hereby extended. Any party may file exceptions or briefs by filing the documents with the Chief Clerk of the TCEQ no later than **5:00 p.m. on March 13, 2017**. Any replies to exceptions or briefs must be filed in the same manner by no later than **5:00 p.m. on March 23, 2017**.

Exceptions, briefs, or replies may be filed with the Chief Clerk electronically at <http://www14.tceq.texas.gov/epic/eFiling/> or by filing an original and seven (7) copies with the Chief Clerk of the TCEQ. To be considered timely, any exceptions, briefs, or replies must be received by the Chief Clerk on or before the applicable 5:00 P.M. deadline. All filings should be addressed to the attention of the Agenda Docket Clerk and should be marked with the TCEQ and SOAH docket numbers provided above. All filings should also be mailed to all other persons on the attached mailing list on the same day mailed or filed with the Chief Clerk. Exceptions, briefs, and replies should also be filed with the State Office of Administrative Hearings.
